### ORDER

**Dated 19.12.2019**

1. The Commission took up the Petitions at 3 PM and initiated the proceeding by directing the Petitioner to give a brief on the Petitions filed before the Commission.
2. The Petitioner explained in brief on their petitions.
3. The Commission noted that Technical Validation Session on the said Petition was held on **December 17, 2019** in presence of Officials of the Commission and representatives of the Petitioner. The data queries have been provided to the Petitioner immediately after the Technical Validation Session (TVS).
4. After hearing the submissions of APDCL, the Commission directed as under:
  - I. The Petitioner will submit the Tariff Formats to the Commission on or before **December 23, 2019** and the replies to queries/data gaps raised during TVS on or before **January 10, 2020**.
  - II. The Petitioner will publish the abridged form of the Petition, inviting comments from Stakeholder in soft and hard form, in the English newspaper on **December 27, 2019** and in Regional language newspaper on **December 28, 2019**. The Petitioner shall also upload the Petition on its website on **December 27, 2019**. The Petitioner is directed to submit the copy of published abridged form of the Petition to the Commission thereafter.
  - III. Stakeholders may be provided a time upto January 21, 2020 for submission of their comments on Petition.
  - IV. Further, the Petitioner is directed to publish small advertisement on **December 29, 2019** in few other newspapers stating that the copy of the Petition is made available on its website.
  - V. The Commission also directed its Officials to make the copy of the Petition available on its website by **December 27, 2019**.
  - VI. The Petitioner is further directed to submit its replies to all comments received from Stakeholders by January 31, 2020.

The **Petition No.7, 8 & 9/2019** is admitted subject to subsequent submission of pending information/replies of data queries by the Petitioner.
