Sub: Erratum in the Tariff Order dated 21-11-2013 of APDCL for FY 2013-16

Sir,

With reference to the letters as mentioned above, I am directed to inform you about the following inadvertent typing errors in the Tariff Order in respect of APDCL for the FY 2013-16, issued by the Commission on 21.11.2013. The inadvertent error is very much regretted.

1. The TOD tariff of the HT Category V(C): HT-II Industries has been wrongly typed in the "Schedule of Tariff" (Chapter-8) in the Tariff Order. The correct TOD tariff for the said category is provided as below-

Description	Energy Charge
Time	Rs./kWh
0600-1700 hrs (normal)	5.48
1700-2200 hrs(peak)	6.93
2200-0600 hrs (night)	4.98

However, for the said category the normal/non-TOD tariff has been printed correctly.

2. In the Note, below the Table 5.2 - (under clause 5.3 of Chapter 5 - Tariff Principles and Design) of the Tariff Order, the sentence "**The above determined rates full cost recovery tariff schedule (Table5.2) shall become operative*" should be replaced as "**The above determined rates for LT-I Jeevan Dhara*

and LT II(A) Domestic A Category are contingent on payment of subsidy as agreed by the Government of Assam, failing which, the rates contained in the full cost recovery tariff schedule(Table 5.1) shall become operative."


