ORDER

1. Assam Power Generation Corporation Ltd (APGCL) has filed a Petition (registered as Petition No. 18 of 2017) for approval of Provisional Tariff for 70 MW Lakwa Replacement Power Project (LRPP) for FY 2018-19
2. As scheduled, a Hearing was held on 31.07.2017. During the Hearing, APGCL submitted that, the project execution is in progress and accordingly, the LRPP will get commissioned by 01.04.2018. In the Petition, the Petitioner has sought a Fixed Charge of Rs 0.60/unit and Energy Charge of Rs 1.37/unit. However, considering change in Gas price, the Energy Price may vary.
3. APDCL submitted that, even though the proposed Tariff seems to be in order, the major factor that impacts the power purchase planning of APDCL is the date of commissioning of the projects. APDCL requested that, APGCL should take all efforts to ensure commissioning of LRPP as per the proposed schedule i.e. on 01.04.2018
4. Considering the submissions made by APGCL & APDCL the Commission orders the following:
 - a. The Petition No 18/2017 is hereby admitted.
 - b. APDCL to submit its detail comment on the Petition on or before 15.12.2017
 - c. The Petitioner shall submit their replies on the submission of APDCL on or before 22.12.2017.
 - d. Both the Petitioner and Respondent shall serve copy of their submissions to the opposite party, while submitting the same to the Commission.
