## Terms and Conditions for Printing of Tariff Order for the FY 2016-17, 2017-18 and 2018-19

- 1) Selected printing firms have to collect the manuscript of Tariff Order for the FY 2017-18 passed by the Honourable Commission from AERC Office at ASEB Campus, Dwarandhar, G. S. Road, Six Mile, Guwahati - 781022, on intimation from the Commission's Office and maintain utmost secrecy.
- 2) The printing of Tariff Order must be clear without any defects/errors and must be of excellent perfect hard binding.
- 3) Printed Tariff Order must be submitted within 10 (ten) days as per work order issued by the Commission.
- 4) Printing must be in A4 size of J. K. Copier paper.
- 5) Cover page must be of multicolor 300 GSM Art Board paper with mat lamination.
- 6) Total numbers of Tariff Orders (3 x 120) = 360 copies each for English and Assamese.
