### **NOTICE**

**(Provision of previous publication under Sub-Section 3 of Section 181 of  
The Electricity Act, 2003)**

**Sub: Draft AERC (Renewable Purchase Obligation and its Compliance)  
Regulations, 2010,(Amendment),2015.**

The existing AERC(Renewable Purchase Obligation and its Compliance) Regulations, 2010, notified in the year 2010 the minimum percentage of Renewable Energy to be purchased by an obligated entity out of the total energy handled was fixed up to FY2014-15 only. Thus, the minimum percentage of Renewable energy to be purchased by an obligated entity out of the total energy handled beyond the FY2014-15 is required to be fixed by the Commission.

Therefore, the Commission has now decided to amend the AERC(Renewable Purchase Obligation and its Compliance) Regulations, 2010. The Draft Amended Regulations with title AERC(Renewable Purchase Obligation and its Compliance) Regulations, 2010,(Amendment),2015 have been prepared accordingly. These Regulations shall supersede the existing AERC(Renewable Purchase Obligation and its Compliance) Regulations, 2010,.

The proposed AERC(Renewable Purchase Obligation and its Compliance) Regulations, 2010,(Amendment),2015 are also placed in the official website of the Commission, [www.aerc.gov.in](http://www.aerc.gov.in) in "Regulations" Page as previous publication under sub-section (3) of Section 181 of the Electricity Act, 2003. Any person/body corporate who is likely to be affected by the provision of these Regulations, may submit his comments / objections, suggestions to the Assam Electricity Regulatory Commission on or before 16<sup>th</sup> March, 2015.
