**(Provision of previous publication under Sub-Section 3 of Section 181 of
The Electricity Act, 2003)**

Sub: Draft AERC (Payment of Fees etc.) Regulations, 2015.

The existing AERC (Fees) Regulations, 2009 notified in the year 2010 need some major changes in order to accommodate the provisions laid down under various Sections of the Electricity Act, 2003 for submission of different types of Petitions/Applications to the Commission, and levying fees thereof.

Therefore, the Commission has now decided to draft the AERC (Payment of Fees etc.) Regulations, 2015. The Draft Regulations have been prepared in line with the Fees Regulations passed by the Electricity Regulatory Commissions of other States of the country. These Regulations shall supersede the AERC (Fees) Regulations, 2009.

The proposed AERC (Payment of Fees etc.) Regulations, 2015 are also placed in the official website of the Commission, www.aerc.gov.in in "Regulations" Page as previous publication under sub-section (3) of Section 181 of the Electricity Act, 2003. Any person/body corporate who is likely to be affected by the provision of these Regulations, may submit his comments / objections, suggestions to the Assam Electricity Regulatory Commission on or before 16th February, 2015.
