The Electricity Act, 2003)**

**Sub: Draft AERC (Constitution of the State Advisory Committee and its
Functions) Regulations (First Amendment), 2017.**

The AERC (Constitution of State Advisory Committee and its Function) Regulations, 2004 was notified on 10th December, 2004. In these Regulations, the sitting fee for the members other than ex-officio members was fixed at Rs 500/- per sitting. The Hon'ble Commission is of the opinion that the fee of Rs 500/- paid to the members need to be revised from time to time in line with other State Electricity Regulatory Commissions keeping in mind inflationary and other factors.

Accordingly, the relevant provision in the aforementioned Regulations is proposed to be amended and a draft AERC (Constitution of the State Advisory Committee and its Functions) Regulations (First Amendment), 2017 has been prepared.

The draft AERC (Constitution of the State Advisory Committee and its Functions) Regulations (First Amendment), 2017 is also being placed in the official website of the Commission, www.aerc.gov.in in "Regulations" Page as previous publication under sub-section (3) of Section 181 of the Electricity Act, 2003. Any person/body corporate who is likely to be affected by the provision of these Regulations, may submit his comments / objections, suggestions to the Assam Electricity Regulatory Commission on or before 30th June, 2017.
